I. Welcome & Introductions – Meghan Harder

II. Principal Report-Megan Lippert

IV. Treasurer's Report-Everett Bradley and Arlene Swanson

We have \$31,000 in checking account and \$22,000 in Money Market. Fundraising has been low this year. Need to get a copy of the Papa John's pizza receipt for reimbursement for 8th grade fall social. Catherine Shapiro and Meghan Harder are working on it. Board will schedule a mid year budget review to prepare for the remainder of year and Mini Grants Review in March. Ana Ly made the motion to approve January Monthly Budget Report and Kim Ayars seconded, all in favor.

V. President's Report-Meghan Harder

School Supply update-we have a chair and a couple of parents who are willing to assist in August with the School Supply Pick up date. Tricia Everson will be chairing the committee. We have talked with A+ School Supplies rep, Greg Born and will be providing him with grade level supply lists on March 2. Mike Robertson has been working with team leaders to insure this deadline is met.

Food Truck Fridays-Meghan is meeting with UASD Nutritional Services Director, Irene Hunt, this week to discuss the possibility of bringing back Fusion and some other food trucks once before spring break and 4-5 Fridays after break.

Mini Grants are voted on next month. We will have a budget review to see how much we have available to spend. We also need to review our policy on requests from extra-curricular clubs. Ana Ly suggested sending out a separate email regarding the NFF to see if that brings in more responses/donations. MH will do that this week.

5th grade orientation is February 5th and we need to offer Spirit Wear sales at the event. MH will reach out to SW Committee. AS mentioned that there have been no requests for money or squares.

VI. Committee Reports/Old Business
